 - d "the Academy Trust" means the company intended to be regulated by these Articles and referred to in Article 2,
 - e "the Articles" means these Articles of Association of the Academy Trust,
 - f "chairman" means the chairman of the Trustees, save that for the purposes of Articles 23-44 it shall refer instead to the individual appointed as chairman of a General Meeting pursuant to Article 25,
 - g Not used,
 - h "clear days" in relation to the period of a notice means the period excluding the day when the notice is given or deemed to be given and the day on which it is given or on which it is to take effect,
 - "Clerk"means the clerk to the Trustees or any other person appointed to perform the duties of the clerk to the Trustees, including a joint, assistant or deputy clerk,
 - "Co-opted Trustee" has the meaning contained in Article 58,
 - k "Companies Acts" means the Companies Acts (as defined in section 2 of the Companies Act 2006), in so far as they apply to the Academy,

- The company's name is **Yavneh College Academy Trust** (and in this document it is called "**the Academy Trust**")
- 3 The Academy Trust's registered office is to be situated in England and Wales

OBJECT

- The Academy Trust's object ("**the Object**") is specifically restricted to the following
 - to advance for the public benefit education in the United Kingdom, in particular but without prejudice to the generality of the foregoing, by establishing, maintaining, carrying on, managing and developing a school ("the **Academy**") with a designated Jewish religious character offering a broad and balanced curriculum conducted as an Orthodox Jewish school under the religious authority of the Chief Rabbi both generally and in particular in relation to arranging for religious education and daily acts of

- worship (as required by the Funding Agreement)
- to promote for the benefit of the inhabitants of Borehamwood and the surrounding area the provision of facilities for recreation or other leisure time occupation of individuals who have need of such facilities by reason of their youth, age, infirmity or disablement, financial hardship or social and economic circumstances of for the public at large in the interests of social welfare and with the object of improving the condition of life of the said inhabitants
- In furtherance of the Object but not further or otherwise the Academy Trust may exercise the following powers
 - a to draw, make, accept, endorse, discount, execute and issue promissory notes, bills, cheques and other instruments, and to operate bank accounts in the name of the Academy Trust,
 - to raise funds and to invite and receive contributions provided that in raising funds the Academy Trust shall not undertake any substantial permanent trading activities and shall conform to any relevant statutory regulations,
 - to acquire, alter, improve and (subject to such consents as may be required by law) to charge or otherwise dispose of property,
 - d subject to Articles 6 6-6 8 below to employ such staff, as are necessary for the proper pursuit of the Object and to make all reasonable and necessary provision for the payments of pensions and superannuation to staff and their dependants,
 - e to establish or support, whether financially or otherwise, any charitable companies, trusts, associations or institutions formed for all or any of the Object,
 - to co-operate with other charities, other independent and maintained schools, academies and institutions within the further education sector, voluntary bodies and statutory authorities operating in furtherance of the Object and to exchange information and advice with them,

- g to pay out of funds of the Academy Trust the costs, charges and expenses of and incidental to the formation and registration of the Academy Trust,
- h to establish, maintain, carry on, manage and develop the Academies at locations to be determined by the Trustees,
- to offer scholarships, exhibitions, prizes and awards to pupils former pupils, and otherwise to encourage and assist the educational attainment of pupils and former pupils,
- to provide educational facilities and services to students of all ages and the wider community for the public benefit,
- to carry out research into the development and application of new techniques in education and to their approach to curriculum development and delivery and to publish the results of such research, and to develop means of benefiting from application of the experience of industry, commerce, other schools, educational institutions and the voluntary sector to the education of pupils and students in academies,
- subject to such consents as may be required by law and/or by any contract entered into by or on behalf of the Academy Trust, to borrow and raise money for the furtherance of the Object in such manner and on such security as the Academy Trust may think fit,
- m to deposit or invest any funds of the Academy Trust not immediately required for the furtherance of its Object (but to invest only after obtaining such advice from a financial expert as the Trustees consider necessary and having regard to the suitability of investments and the need for diversification),
- n to delegate the management of investments to a financial expert, but only on terms that
 - the investment policy is set down in writing for the financial expert by the Trustees.

- every transaction is reported promptly to the Trustees,
- the performance of the investments is reviewed regularly with the Trustees,
- the Trustees are entitled to cancel the delegation arrangement at any time.

- to arrange for investments or other property of the Academy Trust to be held in the name of a nominee company acting under the control of the Trustees or of a financial expert acting under their instructions, and to pay any reasonable fee required,
- to provide indemnity arrangements to Trustees in accordance with, and subject to the conditions of section 232 to 235 of the Companies Act 2006, section 189 of the Charities Act 2011 or any other provision of law applicable to charitable companies and any such indemnity is limited accordingly,

- r to establish subsidiary companies to carry on any trade or business for the purpose of raising funds for the Academy Trust, and
- s to do all such other lawful things as are necessary for or are incidental to or conducive to the achievement of the Object
- 6.1 The income and property of the Academy Trust shall be applied solely towards the

- None of the income or property of the Academy Trust may be paid or transferred directly or indirectly by way of dividend bonus or otherwise by way of profit to any Member of the Academy Trust Nonetheless a Member of the Academy Trust who is not also a Trustee may
 - a benefit as a beneficiary of the Academy Trust,
 - b be paid reasonable and proper remuneration for any goods or services supplied to the Academy Trust,
 - be paid rent for premises let by the Member of the Academy Trust if the amount of the rent and other terms of the letting are reasonable and proper, and
 - d be paid interest on money lent to the Academy Trust at a reasonable and proper rate, such rate not to exceed 2 per cent per annum below the base lending rate of a UK clearing bank selected by the Trustees, or 0 5%, whichever is the higher
- 6 2A The Trustees may only rely upon the authority provided by Article 6 2 to allow a benefit to a Member if each of the following conditions is satisfied
 - a the remuneration or other sums paid to the Member do not exceed an amount that is reasonable in all the circumstances,
 - the Trustees are satisfied that it is in the interests of the Academy Trust to contract with that Member rather than with someone who is not a Member In reaching that decision the Trustees must balance the advantage of contracting with a Member against the disadvantages of doing so, and
 - the reason for their decision is recorded by the Trustees in the minute book
- A Trustee may benefit from any indemnity arrangement purchased at the Academy Trust's expense to cover the liability of the Trustees which by virtue of any rule of law would otherwise attach to them in respect of any negligence, default or breach of trust or breach of duty of which they may be guilty in relation to the Academy Trust

- b sell goods, services, or any interest in land to the Academy Trust,
- be employed by, or receive any remuneration from the Academy Trust (other than the Principal and any Staff Trustee whose employment and/or remuneration is subject to the procedure and conditions in Article 6 8),
- d receive any other financial benefit from the Academy Trust, unless
 - the payment is permitted by Article 6.7 and the Trustees follow the procedure and observe the conditions set out in Article 6.8, or
 - the Trustees obtain the prior written approval of the Charity

6 7 Subject to Article 6 8, a Trustee may

- c receive interest on money lent to the Academy Trust at a reasonable and proper rate not exceeding 2% per annum below the base rate of a clearing bank to be selected by the Trustees, or 0.5%, whichever is the higher
- d receive rent for premises let by the Trustee to the Academy Trust if the amount of the rent and the other terms of the lease are reasonable and proper
- 6 8 The Academy Trust and its Trustees may only rely upon the authority provided by Article 6 7 if each of the following conditions is satisfied
 - a the remuneration or other sums paid to the Trustee do not exceed an amount that is reasonable in all the circumstances
 - b the Trustee is absent from the part of any meeting at which there is discussion of
 - his or her employment, remuneration, or any matter concerning the contract, payment or benefit, or
 - his or her performance in the employment, or his or her performance of the contract, or
 - any proposal to enter into any other contract or arrangement with him or her or to confer any benefit upon him or her that would be permitted under Article 6.7, or
 - any other matter relating to a payment or the conferring of any benefit permitted by Article 6 7
 - the Trustee does not vote on any such matter and is not to be counted when calculating whether a quorum of Trustees is present at the meeting
 - d save in relation to employing or contracting with the Principal, Staff Trustees or any other Trustee who is an employee of the Academy Trust the other

Trustees are satisfied that it is in the interests of the Academy Trust to employ or to contract with that Trustee rather than with someone who is not a Trustee. In reaching that decision the Trustees must balance the advantage of employing a Trustee against the disadvantages of doing so (especially the loss of the Trustee's services as a result of dealing with the Trustee's conflict of interest)

- e the reason for their decision is recorded by the Trustees in the minute book
- f a majority of the Trustees then in office have received no such payments or benefit

6 8A The provision in Article 6 6 (c) that no Trustee may be employed by or receive any remuneration from the Academy Trust (other than the Principal or a Staff Trustee) does not apply to an existing employee of the Academy Trust who is subsequently elected or appointed as a Trustee save that this clause shall only allow such a Trustee to receive remuneration or benefit from the Academy Trust in his capacity as an employee of the Academy Trust and provided that the procedure as set out in Articles 6 8(b)(i), (ii) and 6 8 (c) is followed

- 7 The liability of the Members of the Academy Trust is limited
- 8 Every Member of the Academy Trust undertakes to contribute such amount as may be required (not exceeding £10) to the Academy Trust's assets if it should be wound up while he or she is a Member or within one year after he or she ceases to be a Member, for payment of the Academy Trust's debts and liabilities before he or she ceases to be a Member, and of the costs, charges and expenses of winding up, and for the adjustment of the rights of the contributors among themselves
- If the Academy Trust is wound up or dissolved and after all its debts and liabilities (including any under section 483 of the Education Act 1996) have been satisfied there remains any property it shall not be paid to or distributed among the Members of the Academy Trust, but shall be given or transferred to some other charity or charities having objects similar to the Object which prohibits the distribution of its or their income and property to an extent at least as great as is imposed on the Academy Trust at or before the time of dissolution and if that cannot be done then to some other charitable object

- 12A No employee of the Academy Trust shall be a Member of the Academy Trust
- 13 Each person entitled to appoint Members in Article 12 shall have the right from time to time by written notice delivered to the Office to remove any Member appointed by them and to appoint a replacement Member to fill a vacancy whether resulting from such removal or otherwise
- 14 If any of the persons entitled to appoint Members in Article 12
 - a in the case of an individual, die or become legally incapacitated,
 - b in the case of a corporate entity, cease to exist and are not replaced by a successor institution,
 - c becomes insolvent or makes any arrangement or composition with their creditors generally, or
 - d ceases to themselves be a Member,

their right to appoint Members under these Articles shall vest in the remaining Members

- 15 Membership will terminate automatically if
 - a Member (which is a corporate entity) ceases to exist and is not replaced by a successor institution,

- e a Member, also being a Trustee, ceases to be a Trustee,
- f a Member refuses to consent to any checks required by the Secretary of State under the provisions of the Relevant Funding Agreements or otherwise, or
- g a Member is found to be unsuitable to be a Member by the Secretary of State under the provisions of the Relevant Funding Agreements
- 15A The Members, with the written consent of the Foundation Trust, may agree by passing a special resolution to appoint such additional Members as they think fit
- In addition to Article 13, the Members may agree by passing a special resolution to remove any Member(s) The Member whose proposed removal is the subject of the resolution shall not be entitled to vote on that resolution
- 16A In exercising their rights under these Articles and the Companies Act 2006, the Members shall not do anything or take any action which would cause the Academy Trust to contravene its Object
- 17 Every person nominated to be a Member of the Academy Trust shall sign a written consent to become a Member or sign the register of Members on becoming a Member
- Any Member may resign provided that after such resignation the number of Members is not less than three. A Member shall cease to be one immediately on the receipt by the Academy Trust of a notice in writing signed by the person or persons entitled to remove him under Articles 13 or 16 provided that no such notice shall take effect when the number of Members is less than three unless it contains or is accompanied by the appointment of a replacement Member.

NOTICE OF GENERAL MEETINGS

- General meetings shall be called by at least fourteen clear days' notice but may be called by shorter notice if it is so agreed by a majority in number of Members having a right to attend and vote and together representing not less than 90% of the total voting rights at that meeting
- 21A The notice shall specify the time and place of the meeting and the general nature of the business to be transacted. The notice shall also state that the Member is entitled to appoint a proxy. The notice shall be given to all the Members, to the Trustees and auditors.
- The accidental omission to give notice of a meeting to, or the non-receipt of notice of a meeting by, any person entitled to receive notice shall not invalidate the proceedings at that meeting

PROCEEDINGS AT GENERAL MEETINGS

- No business shall be transacted at any meeting unless a quorum is present. A Member counts towards the quorum by being present either in person or by proxy. The Trustees shall appoint the Executive Headteacher and the Principals of the Academies The Trustees may delegate such powers and functions as they consider are required by the Executive Headteacher and the Principals for the internal organisation, management and control of the Academies (including the implementation of all policies approved by the Trustees and for the direction of the teaching and curriculum at the Academies)

MEETINGS OF THE TRUSTEES

- 108 Subject to these Articles, the Trustees may regulate their proceedings as they think fit
- The Trustees shall hold at least three meetings in every school year. Meetings of the Trustees shall be convened by the Clerk. In exercising his functions under this Article the Clerk shall comply with any direction.
 - a given by the Trustees, or
 - b given by the chairman of the Trustees or, in his absence or where there is a vacancy in the office of chairman, the vice-chairman of the Trustees, so far as such direction is not inconsistent with any direction given as mentioned in (a)
- Any three Trustees may, by notice in writing given to the Clerk, requisition a meeting of the Trustees, and it shall be the duty of the Clerk to convene such a meeting as soon as is reasonably practicable
- 111 Each Trustee shall be given at least seven clear days before the date of a

meeting

- a notice in writing thereof, signed by the Clerk, and sent to each Trustee at the address provided by each Trustee from time to time, and
- b a copy of the agenda for the meeting,

provided that where the chairman or, in his absence or where there is a vacancy in the office of chairman, the vice-chairman, so determines on the ground that there are matters demanding urgent consideration, it shall be sufficient if the written notice of a meeting, and the copy of the agenda thereof are given within such shorter period as he directs

- The convening of a meeting and the proceedings conducted thereat shall not be invalidated by reason of any individual not having received written notice of the meeting or a copy of the agenda thereof
- 113 A resolution to rescind or vary a resolution carried at a previous meeting of the Trustees shall not be proposed at a meeting of the Trustees unless the consideration of the rescission or variation of the previous resolution is a specific item of business on the agenda for that meeting
- 114 A meeting of the Trustees shall be terminated forthwith if
 - a the Trustees so resolve, or
 - b the number of Trustees present ceases to constitute a quorum for a meeting of the Trustees in accordance with Article 117, subject to Article 119

- 115 Where in accordance with Article 114 a meeting is not held or is terminated before all the matters specified as items of business on the agenda for the meeting have been disposed of, a further meeting shall be convened by the Clerk as soon as is reasonably practicable
- 116 Where the Trustees resolve in accordance with Article 114 to adjourn a meeting before all the items of business on the agenda have been disposed of, the Trustees shall before doing so determine the time and date at which a further meeting is to be held for the purposes of completing the consideration of those items, and they shall direct the Clerk to convene a meeting accordingly
- 117 Subject to Article 119, the quorum for a meeting of the Trustees, and any vote on any matter thereat, shall be any three Trustees, or where greater, any one third (rounded up to a whole number) of the total number of Trustees holding office at the date of the meeting, who are in each case present at the meeting and entitled to vote on the matters to be resolved
- The Trustees may act notwithstanding any vacancies in their number, but, if the numbers of Trustees is less than the number fixed as the quorum, the continuing Trustees may act only for the purpose of filling vacancies or of calling a General Meeting
- 119 The quorum for the purposes of
 - a any vote on the removal of a Trustee in accordance with Article 66, and
 - b any vote on the removal of the chairman of the Trustees in accordance with Article 90.

shall be any two-thirds (rounded up to a whole number) of the persons who are at the time Trustees present at the meeting and entitled to vote on those respective matters

Subject to these Articles, every question to be decided at a meeting of the Trustees shall be determined by a majority of the votes of the Trustees present and voting on the question. Every Trustee shall have one vote

- Subject to Articles 117-119, where there is an equal division of votes, the chairman of the meeting shall have a casting vote in addition to any other vote he may have
- 122 The proceedings of the Trustees shall not be invalidated by

 - b any defect in the election, appointment or nomination of any Trustee
- 123 A resolution in writing, signed by all the Trustees entitled to receive notice of and vote at a meeting of Trustees or of a committee of Trustees, shall be valid and effective as if it had been passed at a meeting of Trustees or (as the case may be) a committee of Trustees duly convened and held. Such a resolution may consist of several documents in the same form, each signed by one or more of the Trustees.
- 124 Subject to Article 125, the Trustees shall ensure that a copy of
 - a the agenda for every meeting of the Trustees,
 - b the draft minutes of every such meeting, if they have been approved by the person acting as chairman of that meeting,
 - c the signed minutes of every such meeting, and
 - d any report, document or other paper considered at any such meeting, are, as soon as is reasonably practicable, made available at every Academy to persons wishing to inspect them
- 125 There may be excluded from any item required to be made available in pursuance of Article 124, any material relating to
 - a named teacher or other person employed, or proposed to be employed, at any Academy,
 - b a named pupil or named student at, or candidate for admission or referral to, any Academy, and
 - c any matter which, by reason of its nature, the Trustees are satisfied should

remain confidential

- 126 Any Trustee shall be able to participate in meetings of the Trustees by telephone or video conference provided that
 - a he has given notice of his intention to do so detailing the telephone number on which he can be reached and/or appropriate details of the video conference suite from which he shall be taking part at the time of the meeting at least 48 hours before the meeting, and
 - the Trustees have access to the appropriate equipment if after all reasonable efforts it does not prove possible for the person to participate by telephone or video conference the meeting may still proceed with its business provided it is otherwise quorate

PATRONS AND HONORARY OFFICERS

The Trustees may from time to time appoint any person whether or not a Member of the Academy Trust to be a patron of the Academy Trust or to hold any honorary office and may determine for what period he is to hold such office

THE SEAL

The seal, if any, shall only be used by the authority of the Trustees or of a committee of Trustees authorised by the Trustees. The Trustees may determine who shall sign any instrument to which the seal is affixed and unless otherwise so determined it shall be signed by a Trustee and by the Clerk or by a second Trustee.

ACCOUNTS

Accounts shall be prepared in accordance with the relevant statement of recommended practice published by the Charity Commission from time to time (the "Statement of Recommended Practice") as if the Academy Trust was a non-exempt charity and with Parts 15 and 16 of the Companies Act 2006 and the Academy Trust shall file these with the Secretary of State and the Principal Regulator by 31 December each Academy Financial Year

ANNUAL REPORT

130 The Trustees shall prepare their Annual Report in accordance with the Statement of Recommended Practice as if the Academy Trust was a non-exempt charity and shall file this with the Secretary of State and the Principal Regulator by 31 December each Academy Financial Year

ANNUAL RETURN

The Trustees shall comply with their obligations under Part 24 of the Companies Act 2006 (or any statutory re-enactment or modification of that Act) with regard to the preparation of an annual return to the Registrar of Companies

NOTICES

- Any notice to be given to or by any person pursuant to the Articles (other than a notice calling a meeting of the Trustees) shall be in writing or shall be given using electronic communications to an address for the time being notified for that purpose to the person giving the notice. In these Articles, "Address" in relation to electronic communications, includes a number or address used for the purposes of such communications.
- 133 A notice may be given by the Academy Trust to a Member either personally or by sending it by post in a prepaid envelope addressed to the Member at his registered address or by leaving it at that address or by giving it using electronic communications to an address for the time being notified to the Academy Trust by the Member A Member whose registered address is not within the United Kingdom and who gives to the Academy Trust an address within the United Kingdom at which notices may be given to him, or an address to which notices may be sent using electronic communications, shall be entitled to have notices given to him at that address, but otherwise no such Member shall be entitled to receive any notice from the Academy Trust
- 134 A Member present, either in person or by proxy, at any meeting of the Academy Trust shall be deemed to have received notice of the meeting and, where necessary, of the purposes for which it was called
- 135 Proof that an envelope containing a notice was properly addressed, prepaid and posted shall be conclusive evidence that the notice was given Proof that a notice contained in an electronic communication was sent in accordance with guidance issued

INDEMNITY

Subject to the provisions of the Companies Act 2006 and Article 6.3 every Trustee or other officer or auditor of the Academy Trust shall be indemnified out of the assets of the Academy Trust against any liability incurred by him in that capacity in defending any proceedings, whether civil or criminal, in which judgment is given in favour or in which he is acquitted or in connection with any application in which relief is granted to him by the court from liability for negligence, default, breach of duty or breach of trust in relation to the affairs of the Academy Trust

RULES

- 137 The Trustees may from time to time make such rules or bye laws as they may deem necessary or expedient or convenient for the proper conduct and management of the Academy Trust and for the purposes of prescribing classes of and conditions of membership, and in particular but without prejudice to the generality of the foregoing, they may by such rules or bye laws regulate
 - the admission and classification of Members of the Academy Trust (including the admission of organisations to membership) and the rights and privileges of such Members, and the conditions of membership and the terms on which Members may resign or have their membership terminated and the entrance fees, subscriptions and other fees or payments to be made by Members,
 - b the conduct of Members of the Academy Trust in relation to one another, and to the Academy Trust's servants,
 - the setting aside of the whole or any part or parts of the Academy Trust's premises at any particular time or times or for any particular purpose or purposes.

AVOIDING INFLUENCED COMPANY STATUS

- Notwithstanding the number of Members from time to time, the maximum aggregate number of votes exercisable by Local Authority Associated Persons shall never exceed 19 9% of the total number of votes exercisable by Members in general meeting and the votes of the other Members having a right to vote at the meeting will be increased on a pro-rata basis
- No person who is a Local Authority Associated Person may be appointed or elected as a Trustee if, once the appointment or election had taken effect, the number of Trustees who are Local Authority Associated Persons would represent 20% or more of the total number of Trustees. Upon any resolution put to the Trustees, the maximum aggregate number of votes exercisable by any Trustees who are Local Authority. Associated Persons shall represent a maximum of 19.9% of the total number of votes cast by the Trustees on such a resolution and the votes of the other Trustees having a right to vote at the meeting will be increased on a pro-rata basis.
- 141 No person who is a Local Authority Associated Person is eligible to be appointed or elected to the office of Trustee unless his appointment or election to such office is authorised by the local authority to which he is associated
- 142 Not used
- 143 If at any time the number of Trustees or Members who are also Local Authority

Associated Persons would (but for Articles 139 to 142 inclusive) represent 20% or more of the total number of Trustees or Members (as the case may be) then a sufficient number of the Trustees or Members (as the case may be) who are Local Authority Associated Persons shall be deemed to have resigned as Trustees or Members (as the case may be) immediately before the occurrence of such an event to ensure that at all times the number of such Trustees or Members (as the case may be) is never equal to or greater than 20% of the total number of Trustees or Members (as the case may be) Trustees or Members (as the case may be) who are Local Authority Associated Persons shall be deemed to have resigned in order of their appointment or election date the most recently appointed or elected resigning first

144 The Members will each notify the Academy Trust and each other if at any time they believe that the Academy Trust or any of its subsidiaries has become subject to the influence of a local authority (as described in section 69 of the Local Government and Housing Act 1989)


